No. 22-001-SE, submitted by Jason Ferrell, on behalf of himself as one of two property owners, and Dowling R. Watford, Jr., Personal Representative for Martha B. Watford, as Trustee of the Martha B. Watford Revocable Trust U/A Dated April 12, 2005, the second property owner. The request is to allow outdoor sales and storage, building trades contractor in a Heavy Commercial (CHV) zoning district, as allowed by Code of Ordinances Section 90-283(5). The Ferrell property is located at 800 NW Park Street and is 0.33+/- acres with two existing structures.
