All materials, installations, and performance of work are subject to inspection and approval by the City of Okeechobee Public Works Department.

Owner of utility agrees to maintain permitted facility, including restoration of the surrounding right-of-way, at its sole expense and, if requested by the City of Okeechobee, to promptly modify, relocate, and/or remove said facility as requested at the utility owner's sole expense. All portions of the public right-of-way disturbed or impaired during the construction, maintenance, relocation, or removal of the permitted facility shall be restored at the owners or utility owner's sole expense and the City of Okeechobee will have no responsibility thereafter.

Public Safety and Traffic shall be maintained during all periods of construction in accordance with the provisions of Florida Department of Transportation design standards Index 600 and section 6 of the Manual of Uniform Traffic Control Devices, current edition.

\_\_\_\_\_ When excavation is included in this permit, utility location services, "Call Before you Dig" procedures in accordance with section 563.85 Florida Statutes will be strictly followed. Fines for failure to comply with location requirements will be assessed in accordance to section 556.107 Florida Statutes.
